THE ARCHITECT SHALL NOT BE RESPONSIBLE FOR ANY DELAYS OR COSTS INCURRED BY THE CLIENT AS A RESULT OF THE CLIENT'S FAILURE TO OBTAIN ALL NECESSARY PERMITS AND APPROVALS.
